

e) to jointly propose and engage in research or training programmes sponsored by funding agencies, and to invite each other's faculty to participate therein.
f) to exchange, on a reciprocal basis, students at Undergraduate, Graduate and Doctoral levels for limited periods of time for purpose of education and /or research.

Late Chhaganlal Muljibhai Kadhi Kala Mahavidyalaya, Achalpur Camp and Arts, Commerce College, Yeoda further agree that detailed terms and conditions that guide each activity identified above will be separately determined and agreed upon by the two institutions. These terms shall include a technical description of the proposed activity, financial arrangements, and person(s) responsible for its implementation, etc.

## B. Joint Sponsored Research, Development and Consulting

## C. Exchange of Faculty, Scientists and Staff

Late Chhaganlal Muljibhai Kadhi Kala Mahavidyalaya, Achalpur Camp and Arts, Commerce College, Yeoda agree to encourage collaboration between faculty and staff from the two institutions. Specifically, institutions will encourage members of their faculties to undertake short visits to, or take up fixed-term visiting assignments at, each other's institution as per the existing norms. Terms and conditions for each visit or an assignment, including those concerning stipend, travel, and housing, name of the concerned faculty member will be worked out between Late Chhaganlal Muljibhai Kadhi Kala Mahavidyalaya, Achalpur Camp. and Arts, Commerce College, Yeoda.

D. Student Exchange

Late Chhaganlal Muljibhai Kadhi Kala Mahavidyalaya, Achalpur Camp and Arts, Commerce College, Yeoda agree that student exchange will be guided by principles listed below. A home institution refers to the institution where a student is a full-time student, and from where he/she is expected to graduate. A host institution refers to an institution that receives a student for a brief period of time to undertake a pre-determined programme of study or research. a) Exchange students will be selected by mutual agreement between the home institution and the host institution.

b) An exchange student will continue to be treated as full-time student at his/her home institution.

c) An exchange student will be considered as full-time "exchange" student at the host institution. d) His/her programme of study at the host institution will be determined by mutual consultation between his/her academic advisor at the home institution and his/her "interim" academic institution. host the by identified advisor e) The host institution will evaluate an exchange student's performance in each course or module, to that effect. issue a letter and grade or marks, award a letter f) The home institution may award to the exchange student credits earned at a host institution, but only after the home institution has established correspondence between courses taken at institution. home the offered at those vis-a-vis institution host the

g) If an exchange student has undertaken research, then the host institution will evaluate the exchange student's performance in the research, and issue a letter to that effect, together with a technical "report" of the research carried out.

h) If an exchange student has undertaken research, then the home institution will take note of the performance evaluation and the technical report, and take steps in accordance with its own procedures.

 Late Chhaganlal Muljibhai Kadhi Kala Mahavidyalaya, Achalpur Camp and Arts, Commerce College, Yeoda agree to provide suitable accommodation and living expenses for student exchange.

j) The exchange students will pay tuition and other fees at their home institution.

#### E. Joint Conferences, workshops and short-term courses

Late Chhaganlal Muljibhai Kadhi Kala Mahavidyalaya, Achalpur Camp and Arts, Commerce College, Yeoda will help<sup>\*</sup> identify and invite faculty members from the other institution to participate in conferences, workshops and short-term courses. The terms and conditions for such participation will be worked out by mutual agreement between Late Chhaganlal Muljibhai Kadhi Kala Mahavidyalaya, Achalpur Camp and Arts, Commerce College, Yeoda.

#### F. Intellectual Property

Late Chhaganlal Muljibhai Kadhi Kala Mahavidyalaya, Achalpur Camp and Arts, Commerce College, Yeoda agree to respect each other's rights to intellectual property. Further, the intellectual property rights that arise as a result of any collaborative research or activity under this MoU will be worked out on a case-by-case basis, and will be consistent with the officially laid down IPR policies of the two institutions.

#### G. Co-ordination

Each institution shall appoint one member of its teaching/research faculty to coordinate the programme on its behalf. Further, a coordination committee, consisting of[a] Principal, Late Chhaganlal Muljibhai Kadhi Kala Mahavidyalaya, Achalpur Camp, or his/her nominee, (b) Principal, Arts, Commerce College, Yeoda or his/her nominee, (c) Programme coordinator from the side of Late Chhaganlal Muljibhai Kadhi Kala Mahavidyalaya, Achalpur Camp, and (d) Programme Coordinator from the side of Arts, Commerce College, Yeoda, will periodically review and identify ways to strengthen cooperation between the two institutions.

H. Tenure and Termination
